24	1. Tobacco Products means any substance containing tobacco leaf, including, but
25	not limited to cigarettes, cigars, pipe tobacco, snuff, chewing tobacco, dipping
26	tobacco or rolling papers, and Electronic Smoking Devices.

27	2. Electronic Smoking Device means an electronic and/or battery-operated device,
28	the use of which may resemble smoking, that can be used to deliver an inhavled

30	dose of nicotine or other substances. "Electronic Smoking Device" includes any
31	such device, whether manufactured, distributed, marketed or sold as an electronic
32	cigarette, an electronic cigar, an electronic cigarillo, an electronic pipe, an
33	electronic hookah, or any other product name or descriptor.

35	3. Vending Machines means any mechanical, electric or electronic self service
36	device which, upon insertion of money, tokens, or any other form of payment,
37	dispenses tobacco products.

39	4. Compliance Check violation means any sale of tobacco products to and/or by a
40	person who is less than eighteen (18) years of age.
